Natural Hazard Mitigation Plan



Over the last year and a half, the Five County Association of Governments (FCAOG) has been involved in the development of the "Five County Association of Governments Natural Hazard Mitigation Plan". At this point in the project we have scheduled two open houses to gain more input from the community.

The FCAOG Natural Hazard Mitigation Plan has been

completed with participation and guidance from the FCAOG Regional Hazard Mitigation Team and as a result of a collaborative effort between the Five County Association of Governments, Utah Department of Public Safety Division of Emergency Services and Homeland Security, public agencies, citizens, elected officials, and public employees of the cities and towns within Beaver, Garfield, Iron, Kane, and Washington Counties. Questionnaires were provided to community leaders, and workshops and public meetings were conducted during plan's development. Public Participation for any planning project is vital, and care was taken to provide many opportunities for public comment and participation. Comments, questions, and discussions were given strong consideration in the development of this plan. All participants collectively met the regulations set forth by Federal Emergency Management Agency (FEMA) in completing the plan.

The goal of this plan is to assist jurisdictions in the five counties of Southwestern Utah in reducing the impact of natural disasters. The plan is intended to promote sound public policy designed to protect citizens, private property, critical facilities, and infrastructure. The plan contains information on the purpose and methods used to develop the plan, a profile of communities within FCAOG, as well as a hazard identification study and a vulnerability analysis of ten hazards: Wildfire; Landslide; Flood; Earthquake; Volcanoes; Drought; Problem Soil; Severe Weather; Insect Infestation; and Radon Gas.

The Five County Association of Governments (FCAOG) will hold two meetings regarding the FCAOG Natural Hazard Mitigation Plan, which was recently completed by the FCAOG and has received preliminary approval by the FEMA.

Prior to adoption, by resolution, of this "multi-jurisdictional" Plan by the local jurisdictions within Beaver, Garfield, Iron, Kane and Washington counties, as well as by each of the counties themselves, the FCAOG is inviting all interested persons to attend one of two scheduled open houses in order to review and comment on the Plan. Both open houses will be held on Wednesday, May 19, 2004.

One open house will be held in the FCAOG Conference Room in the Iron County's Fiddler Canyon Office Building, Lower Level, located at 88 East Fiddler Canyon Road; Cedar City, Utah. This open house will be held between 1:00 P.M. and 2:30 P.M.

Another will be held in the FCAOG Conference Room in the FCAOG Tonaquint Business Center Office Building, 1070 West 1600 South, Building B; St. George, Utah. This open house will be held between 4:00 P.M. and 5:30 P.M.

District Housing Condition Survey


Five County Association of Governments Community and Economic Development staff are working with municipalities throughout the region to gather current housing stock information for inclusion into the rewrite of the District Consolidated Plan. The U.S. Department of Housing and Urban Development (HUD), requires a rewrite of the Plan every five years. To accomplish this task, staff is soliciting assistance from each of the jurisdictions within the Five County region to complete a short form for each home that they have identified as meeting the criteria of severely deteriorated or completely dilapidated. The CED staff are requesting those jurisdictions that have yet to complete and return these forms to do so as soon as possible. Kenneth L. Sizemore, Director of the FCAOG Community & Economic Development Division, has returned to Utah after serving on active duty with Utah's 141st Military Intelligence Battalion, which has been in the Iraq theater over the past year.

Ken has described his year of service which included freezing temperatures at Fort Carson, Colorado, where his unit was first mobilized, to temperatures as high as 150 degrees in Iraq.

In Iraq, Ken said the worst damage was not inflicted by U.S. bombs, but by Iraqi looters that pillaged buildings, taking even the copper wiring and plumbing. Ken said if forces accomplished nothing more than ridding Iraqis of the yoke of Saddam Hussein, then the cost of war was worth it. Ken's son Jacob also served in Iraq.
