

Director's Dialogue

Utah continues to be recognized as one of the bestmanaged states in America. One reason for such accolades is the cooperative means employed to address challenges faced at every level of government.

The Legislature and Governors, past and present, have recognized the value of including local officials in determining how financial resources are allocated. Two examples are the Utah Permanent Community Impact Fund Board and the Small Cities Community Development Block Grant programs. Both of these programs use boards consisting of locally-elected officials to make funding decisions. Both rely on capital improvement priority and project lists developed at the local level. Regional priorities are reflected in such lists.

Recent efforts to further improve state government efficiency include proposals to reconfigure the state Department of Community and Culture. In February, the Division of Housing and Community Development is relocating to state-owned space managed by the Department of Workforce Services (DWS). Legislation has also been proposed that would meld that division into DWS.

Associations of Government deliver most of the services funded by the Division of Housing and Community Development. Local officials are working closely with both the Governor's Office and Legislature to assure that any final reconfiguration of the Department of Community and Culture will retain the unique model of local decision making that has been a hallmark of community development across the state for decades.

February brings a shift in leadership at the Association of Governments. I sincerely wish to thank Beaver County Commissioner **Chad Johnson**, who served as Chairman during the past year. I believe this was his fifth opportunity to serve as Chair during his service as a County Commissioner. **Clare Ramsay**, Garfield County Commissioner, will take on the duties of Chairman. We are also welcoming **Darrin LeFevre**, as the new Washington County Mayor's representative.

A new Chief Financial Officer will also be selected in February to replace **Bob Rasmussen**, who is retiring after more than 33 years of service to the Association of Governments. Senior Health Insurance Program (SHIP)- This year volunteers and staff helped over 2,500 individuals during the Open Enrollment period (Oct 15-Dec 7) with Medicare issues. It was the largest effort to date for our program. We continue our outreach to individuals with low income issues to enroll them in Extra Help and other programs.

RSVP Program- The RSVP volunteers finished a strong year of volunteering and booked over 185,000 hours of service. It is amazing what a bunch of nice people can do when they give so much of themselves to help our communities! We have new opportunities monthly for volunteering, so check in with us.

Foster Grandparent and Senior Companion Programs-Both of these programs have made significant headway this year in number of clients who have been reached. State Route 9 Corridor Geologic-Hazard Study

Professional geologists William (Bill) Lund and Tyler Knudsen with the Utah Geological Survey (UGS) Southern Regional Office have just completed a Geologic-Hazard Study for the SR-9 Corridor.

A public meeting in Springdale on the evening of January 24 was held to present the findings of the study. It was attended by over 40 citizens and officials from the corridor communities.

The purpose of the study was to provide municipal, county, and regional administrative and planning officials with geographic-information-system (GIS) -based information on the kinds and locations of geologic hazards that may affect existing and future development in the corridor study area. The primary geologic hazards affecting the SR-9 corridor are: floods and debris flows; expansive soil and rock; collapsible soil; gypsiferous (soluble) soil and rock; piping and erosion; landslides; rock fall; earthquake surface fault rupture; liquefaction; and earthquake ground shaking.



Public reviewing hazard maps

The principal product of the study was the development of 9 g e o l o g i c - h a z a r d "red-flag" maps covering the study area with each map designed as a stand-alone document that provides information regarding a specific geologic hazard and h a z a r d - mitig atio n recommendations.

The maps are intended as an aid for general planning to indicate where detailed site-specific geologic-hazards investigations are required. The maps are not intended as a substitute for site-specific geotechnical investigations.

Funding for the project was provided by the Utah Permanent Community Impact Fund Board (CIB); the Utah Geological Survey, as well as a contribution from each of the four municipalities in the corridor.

The maps and text are being scientific-peer reviewed by other geologists within UGS and when that process is completed they will be published on the UGS web site: geology.utah.gov (Gary Zabriskie)

Community Impact Board Project List Prioritization Meetings Scheduled



In response to our November 2, 2011 notification, the Community and Economic Development staff at the Five County Association of Governments has received Capital Improvement Lists from many entities who are eligible to apply for funding from the Utah Permanent Community Impact Fund Board (CIB). Eligible applicants include counties, cities, towns, special service districts, and in certain circumstances school districts and public higher education entities. Data provided from the updated Capital Improvement Lists is incorporated by our staff into the CIB project lists - one for each county. These documents are used for funding decisions by the Community Impact Fund Board.

The CIB's policy is that any entity's project(s), in order to be considered for funding, must be on the 1-Year List developed for that entity's county. If your entity has not provided us with an updated 1-Year List or an updated Year-2 to 5 List, the CIB list prioritization meeting in your county will be your final opportunity to add projects to the lists or make any changes prior to the lists being prioritized by consensus of the meeting attendees and closed.

The prioritized 1-Year Lists and Year 2 to 5 Lists will then be submitted to the state CIB staff as the official lists and will be used for CIB applications submitted by entities in the CIB trimester application cycles of June 2012, October 2012 and February 2013.

A local representative (clerk, manager, etc.) or an elected official from all entities which are planning to apply to the CIB during the next year should be in attendance to help organize and prioritize the projects on the lists. The 2012 Dixie Transportation Expo will seek public review and comment of several transportation projects and issues. The annual expo is designed to help a number of federal, state and local governments prioritize

road maintenance, congestion relief, safety, and economic development transportation projects.

Of particular interest this year are projects like Bluff Street, State Route 18, Washington Parkway, East Dixie Drive, 1450 South, Dixie Drive, Red Hills Parkway, and the 30-year Regional Transportation Plan. (See the insert included with this newsletter for a complete list).

The Expo is slated for Tuesday, February 7, 2012 from 11:00 a.m. to 6:00 p.m. at the Dixie Center in St. George. This is an excellent opportunity for government officials and the people they serve to communicate all things transportation.

The 2012 Dixie Transportation Expo seeks public review and comment on several transportation projects and issues on Feb. 7, 2012 from 11 a.m. to 6 p.m. at the Dixie Center in St. George. Projects and sponsoring government agencies are detailed below:

Booth # 1: TravelWise

Penna, Powers, Brian, Haynes staff will address the TravelWise program created by UDOT to implement strategies that encourage Utahans to use alternatives to driving alone.

Booth # 2: UDOT - Know Where Know Why

Intrepid Agency staff will explain a UDOT program which works proactively to communicate construction information to help the driving public plan ahead and avoid inconvenience. This program features various communication tools (including a traffic app now available on the iPhone and Android Smartphones), including an interactive website, text messages, radio announcements and television segments and outreach to lodging properties.

Booth # 3: Bluff Street Environmental Study

HW Lochner will discuss an environmental assessment of a 1.7 mile section of Bluff Street from St. George Blvd. to Red Hills Parkway. The goal is to widen Bluff Street to reduce congestion. This study evaluated traffic operations, conducted public outreach, developed an environmental assessment and has selected a build alternative. Details of the proposed improvements will be available.

Booth #4: SR-18 and I-15 Passing Lanes

UDOT is planning an additional southbound lane on SR-18 from milepost 3.8 to milepost 6.5 (north of Snow Canyon Parkway and south of the Ledges). They are also planning to widen I-15 from milespost 28-30 (in the Toquerville-Leeds area) to accommodate a climbing lane. The purpose of these projects is to reduce congestion and improve safety.

Booth #5: Metropolitan Planning Organization (MPO) and Eastern Washington County Rural Planning Organization Long-Range Planning

The Dixie MPO uses "Vision Dixie" principles, certified population projections, and local land-use plans to determine what roads, trails, transit services, road capacity and safety features will be needed in Washington County's future. A long list of transportation projects such as: Washington Parkway from I-15 exit 13 to State Route 18, Regional Transit Services and coordination, surface streets and intersections near I-15 exits 8 and 10, and Purgatory Road. A map of anticipated road facilities, will be displayed this booth and staff will be available to answer questions.

Booth # 6: City of St. George Public Works Department

Public Works Staff will answer questions about Traffic Signal Projects, Dixie Drive East, 1450 South Widening Riverside Drive and a Pedestrian Crossing Study at I-15 milepost 8.

Booth # 7: City of St. George Municipal Airport

Citizens can look at future plans for the St. George Airport regarding commercial and private air operations and development.

Booth #8: SunTran Bus System

Information will be available regarding routes, times, and future plans for expansion. They will also present the Regional Bus Transit plan and solicit public input regarding routes. Bus Rider's Guides will be available.

Booth #9: Washington City Master Transportation Plan

Washington City staff will be available to discuss the City's Master Transportation Plan.

Booth #10: City of Hurricane

City staff will be available to discuss their Draft Trails and Road Masterplan

Booth #11: City of St. George Trail System

Information will be available regarding the regional trail plan and the status of trail repair required from last vear's flooding.

Booth #12: Dixie Storm Water Pollution Prevention Awareness

This is a coordinated effort by the Cities of St. George, Washington, Ivins and Santa Clara to reduce storm water pollution in local streams and rivers.

Booth #13: URS - Southern Parkway

The Southern Parkway is designed to become a belt route for Washington County that will become a four-lane divided expressway when fully built. The 33-mile parkway begins at I-15, Exit 2, extends east to the St. George Airport, and is planned to go north to SR 9 and reconnects to I-15 at Exit 16.

Booth #14: Red Hills Parkway; Bluff Street to Industrial Road

Horrocks Engineering will explain the roadway widening and related improvements on Red Hills Parkway between Bluff Street and Industrial Road which are in progress at this time. The road is currently two-lane and is being widened to five lanes with full reconstruction of the pavement and related improvements.

Booth #15: I-15 Milepost 0-16 Environmental Assessment

Horrocks Engineering staff will explain the process of conducting an environmental assessment on I-15 between milepost 0-16 in Washington County. It is estimated that by that by 2040 I-15 will lack sufficient capacity for projected traffic volumes on this 16-mile stretch of interstate. This environmental assessment will identify current and future transportation needs within the project area and evaluate alternatives to address impacts on the environment.

Booth #16: Dixie Drive Widening

Rosenberg Associates Staff will be on hand to answer questions regarding the Dixie Drive and Mathis Bridge widening project. Improvements will include: providing two travel lanes in each direction plus adding curb, gutter, sidewalk, and landscaped medians in certain stretches of the road from Mathis Park to Tonaquint Park.

Booth #17: Dixie Drive Interchange

Washington County Constructors have been building this ongoing project which is scheduled to be complete by July 2012. Upon completion, six major structures will have been built including the new Dixie Drive overhead Single Point Interchange, four bridges over the Santa Clara River, the new Dixie Drive structure over Convention Center Drive, collector-distributor roads connecting to the Bluff Street Interchange and re-design of the Confluence Trailhead. Coinciding projects by the City of St. George have upgraded the trail system and adjacent Southgate Golf Course.

Booth #18: Zero Fatalities

Penna, Powers, Brian, Haynes staff will explain Utah's Traffic Safety program. Information will be available on all aspects of traffic safety, from passenger vehicles to commercial motor vehicle. The goal of the Zero Fatalities program is to educate the public and improve safety on Utah's Highways to the degree that there are Zero Fatalities.
