## Dixie Metropolitan Planning Organization Receives Recognition



In 2009 the Dixie Metropolitan Planning Organization (MPO), along with the other MPO's in Utah (Wasatch Front Regional Council, Mountainland Association of Governments, & Cache Metropolitan Planning Organization), and the Utah Department of Transportation were recognized for efforts achieved in developing Utah's "Unified Transportation Plan", a summary of long range needs within the state looking at a horizon from 2007-2030.

This collaboratively developed document summarized the individual plans from the entities noted above which used common planning methods, financial assumptions, and project cost estimates. The Utah State Legislature and Federal Highway Administrations' Salt Lake Division Office supported this effort to develop a unified document, based on common assumptions, to help state, local and regional decision makers compare needs statewide and allocate needed dollars towards projects of highest priority. Three national awards were presented during 2009 to these organizations in Utah in recognition of this 'first in the nation' accomplishment:

Federal Highway Administration recognized their Salt Lake Division Office with FHWA's "2008 Excellence in Planning Oversight Award";

UDOT and Utah's Four MPO's each received the 'American Association of State Highway and Transportation Officials "2008 Presidents Award for Planning Excellence"; and

Utah's Four MPO's each received the Association of Metropolitan Planning Organizations' "2008 National Award for Outstanding Collaboration in Metropolitan Transportation Planning".

Safety Award", at the annual Zero Fatalities Summit, held in September 2009, in Salt Lake City. Lowell was recognized for his leadership in safety efforts throughout his career and specifically to bring the Zero Fatalities Program and message to the attention of local governments and the citizens of southwestern Utah.

The UAC Annual Convention is held every November and is used as an opportunity for elected and non-elected county officials to collaborate on issues, receive training, organize leadership and recognize individuals, and prepare official county positions for the upcoming Utah Legislative Session.

UAC, a not-for-profit organization, is a unified voice for county government, through communication, collaboration, education and training, and responsible management of county issues and resources. The organization represents all 29 Utah counties and 297 elected officials.

### Give a Day, Get a Disney Day Program



When the Disney Corporation introduced their program on New Years Day 2010, Linda Sappington, director of the Volunteer Center Network, saw it as a good thing and thought it just made sense to be involved! She has been reminded of the craziness of that decision, by Volunteer Center staff, nearly every day since as local residents of all ages worked through the process of registration and service, to secure the "golden ticket" to the Magic Kingdom for each member of their family.

"In retrospect, it was an insane idea and we got to the point where we considered Disney a 4-letter word," Sappington states with a laugh! Despite doubling the workload of the already very busy non-profit agency, and the stress

associated with a virtual tidal wave of enthusiastic volunteers, she admits "some really good things have come from all this extra work!"

The Habitat for Humanity ReStore has increased the number of people who know where they are located. Tuacahn Center for the Performing Arts had more than 150 volunteers, on two Saturdays in February, involved in helping them prepare for their upcoming "Broadway in the Desert" summer theater season. The Children's Justice Center, Family Support Center and the DOVE Center have received help with spring cleaning, and community gardens were prepared for planting. School buses were scrubbed down, bike races and road races had volunteers, and nearly 500 receiving blankets and quilts were donated to those suffering in Haiti and Chile.

"It's been very hectic over the past several weeks and we're pleased to be able to get back to our 'real jobs'," states Sappington. Still, the entire staff recognizes the real benefit to the organization is that "a whole lot of people in the community now know there is a volunteer center in Washington County . . . and many have said they will be back to help us mobilize people and resources for creative solutions to community needs."

### Town of Hatch Planning New Community Center

The Garfield County community of Hatch is in the process of having final construction drawings completed for a new multipurpose community center facility. The town of Hatch was a 2009 recipient of a federal Community Development Block Grant (CDBG) administered through the Utah Division of Housing & Community Development and also applied for and received funding of a loan and grant last year from the Utah Permanent Community Impact Fund Board.

The town went through a formal Request for Proposals process to hire a design firm that would meet the needs and desires of the town. At the conclusion of that process the firm of Stempel Form PC Architects of Virgin, Utah was selected for this task. Firm founder Peter Stempel impressed the interview committee when he stated that this was a fantastic opportunity for the town to develop a "downtown", a *community "center"*, in the truest sense of the word.

Stempel Form Architects embarked on a survey and assessment of the current site and existing improvements on the property as well as the surrounding town park in order to integrate the new facility. Several public forums were conducted in which the citizens of the town actively participated in identifying needs and desires for the new facility.

Two key elements were incorporated into the planning for the facility. First, the cinder block structure formerly housing the town's fire equipment would be re-purposed and integrated into the new facility. Secondly, the new facility would be made as energy efficient as possible to lower O&M costs to the town. A ground-source HVAC system is planned to further lower operating costs.
