# Community Services Block Grant (CSBG) Program Update

Five County Association of Governments received \$295,738.00 in FY 2015 Community Services Block Grant (CSBG) funding. Through public-private collaborations and partnerships, these funds were leveraged with other federal, state, local, and private sources to serve low-income households in Beaver, Garfield, Iron, Kane, and Washington counties. These households received transportation, housing, emergency food and shelter, employment supports, free income tax preparation, youth programing, and other services to stabilize families.

Services were provided to the following:

- 8,626 individuals and 2,700 families\*
- 1,404 working households (52%)
- 544 homeless households
- 2,988 seniors
- 465 persons with disabilities

\* This only includes CSBG-eligible clients with intake forms. There are individuals served though other Five County Community Action programs such as VITA, Court Ordered Community Service, Youth Volunteer Corps, Youth Court, food pantry, and rapid re-housing funds not included in this report.

CSBG funding is intended to be used to leverage other resources which assist low-income families. Five County Association of Governments leveraged CSBG funds as follows:

Five County used \$1.00 in CSBG funding to leverage:

- \$15.39 in other federal funding
- \$4.05 in state funding
- \$5.25 in local government funding
- \$4.28 in private funding and in-kind donations
- \$1.88 in volunteer labor

Notable outcomes achieved through Five County Association of Government's FY 2015 Community Action Program include:

### Asset Development:

- VITA volunteers filed 3,327 tax returns, saving working families approximately \$665,400
- VITA volunteers returned \$1,407,000.00 in Earned Income Tax Credit to working families.
- Approximately \$5,000,000 was returned to all five counties.

## **Employment Support:**

- 200 unemployed households gained skills needed for employment
- 90 unemployed households gained employment
- 8 households achieved a living wage and are selfsufficient
- 64 employed households seeking services increased income and/or benefits

#### Housing:

- 108 working households obtained or maintained safe and affordable housing
- 63 chronically homeless, seniors, and persons with disabilities obtained housing.

#### Youth:

- 59 low-income youth avoided risk-taking behavior for over 6 months
- 26 first-time minor offenders were diverted from the juvenile justice system
- Youth collected over 4,000 lbs. of food
- Youth assembled over 1,200 homeless kits
- 176 youth improved social and academic skills
- Youth Volunteer Corps volunteers took place in over 26 community projects which increased the quality of life in Iron and Washington Counties

#### **Success Stories**

"Jane" is a single mother of grown children and a recovering alcoholic. When she received services through the Five County's Community Action program, she had no income and had been homeless for an extended period of time. "Jane" received rapid re-housing assistance through Five County Community Action and supportive services through its partners. With assistance and intensive case management, she obtained employment and renewed her cosmetology license. Through Community Action's Court Ordered Community Service program, she was able to work off a portion of her court fines while engaging in the community. Five County assisted with rapid re-housing. Three months after being placed into housing, "Jane" is now is working full-time and doing hair on the side. She has access to employer-based health insurance, is able to pay her own rent, and provides for her basic needs. She is also a sponsor at AA meetings she attends. "Jane" has said, she finally has life figured out and is able to be engaged in her daughter's life and also her grandchildren's lives. Five County Community Action is thrilled to have been able to support "Jane" as she worked towards selfsufficiency.

"Julie" is a single female with grown children. She was homeless and living at Switchpoint after losing a long-standing rental in Salt Lake City, Utah. She left Salt Lake to get away from triggers after long time meth use, and moved to Kanab with her niece, who had two kids. "Julie" and her niece alternated work schedules to ensure the children had proper supervision. She helped her niece with rent while also saving money for her own place. With case management and support from Five County and Switchpoint, "Julie" finally moved into her own housing, became involved in her church, and became engaged in her daughter's life again. She is currently saving up for a car and rebuilding her credit with the assistance of AAA Fair Credit.

"Ida" fled to Cedar City to escape domestic violence. She was a young single adult rebuilding her life — having nothing more than the clothes on her back. After receiving temporary shelter, clothes, and a few "building blocks" from Canyon Creek Women's Crisis Center, she was referred to Five County for additional services. "Ida" met with a case manager from Five County Community Action. Through bus passes, referrals and coordination with the Utah Department of Workforce Services, and deposit assistance, she worked towards self-sufficiency. She obtained employment that allows her to pay her rent, pay her bills, purchase food, and save for a car. "Ida" is now safe, employed, happy and very proud of the life she is building.

# Childcare Pioneer Passes Away



February 1953 - March 2016

Elisabeth Louise (Lis Barker) Hagen, passed away peacefully on March 10, 2016 in her home in Cedar City, surrounded by her family, after a two-year battle with cancer. Lis was 63 at her passing. A memorial service honoring Lis' life was held March 19th in Cedar City. She will be interred at the Ben Lomond Cemetery in North Ogden.


Until her retirement in 2014, Lis was director of the Five County Association of Government's Child Care Resource and Referral program (now known as Care About Childcare@Five County). Lis worked here for 21 years to educate and train child care providers throughout southern Utah. She was a much sought after lecturer and teacher, presenting at early childhood education conferences throughout Utah and she was an instructor at Southern Utah University for 14 years. Lis was also the author of two books of kindergarten programs currently used throughout Utah.

Lis' love for children will be remembered by the current AOG staff, who continue to build upon her legacy, as well as her many students, child care providers, former children from the preschool she ran from her home and nursery classes, but most importantly her beloved children and grandchildren. Lis was a true champion of children, always fighting to improve their world and protect their childhood.

When she turned 60, rather than giving her gifts, Lis challenged everyone to spend quality time with a child and email her about it. She said: "I saw an article in Child Care Exchange that gave me this idea. I have a request to make of you. If you would like to be a part of making my birthday really FABULOUS then here is my request. Do something with a child: your child, your grandchild, children you take care of, a neighbor... any child. Plan a fun activity." We are asking you to do the same in honor of Lis. She believed that the world could be made a better place one child at a time. In this one way we can honor Lis and follow her example in loving and serving kids.

There is no better way to honor Lis than by carrying on her work by connecting with the special children in our lives. When you do this, tell the children you are doing it in honor of Miss Lizzy, an amazing lady who loved children. Lis was a defender for every child. She never stopped fighting to increase the quality of childcare and improve the life of each child. Every parent in southern Utah who has had their child in childcare, who wants the best for their children, and who seeks out quality early childhood education owes a debt to Lis and the hard work she devoted to that effort. We as her coworkers and friends will truly miss her.

# The Five County AOG Has A Business Loan Program



Do you know a small business that may need capital to start or expand? The Five County AOG has a Revolving Loan Fund (RLF) and a Microloan Fund which were established to create permanent, long-term jobs within the southwestern region of Utah by providing "gap" financing to qualified businesses for eligible activities.

Loans made through the Revolving Loan Fund are intended to help bridge gaps in commercial financing or to fund small start-ups. Funds are repaid into the program and recycled to other businesses, thus "revolving" the same funds.
