Director's Dialogue

Two years ago I noted that "There is much uncertainty about funding and the future of programs in their current state. This is creating a great challenge in crafting a budget for the fiscal year that begins in July. Changes are on the horizon, and not for the first time for our region. I am confident that our history of working cooperatively will allow us to weather the storm of uncertainty and emerge with a slate of programs that will continue to provide a means to benefit all who call southwestern Utah home."

Uncertainty continues to rage across the nation in this election year. The House of Representatives recently voted to delay mandated federal spending cuts in defense by shifting more reductions to discretionary programs. The Social Services Block Grant (SSBG) is slated for elimination. Pundits give little chance for SSBG elimination in the Senate. In our region, SSBG funds a significant portion of county senior citizen transportation programs. Should the budget assume that SSBG survives or dies?

At the same time federal transportation programs are operating on the 9th extension of an authorization that expired in 2008. A conference committee is currently trying to craft an acceptable transportation program to avoid a 10th extension, the likely result in this election year.

Given this uncertainty, it is difficult to refine a budget that reflects more than a status quo approach, with the understanding that any dramatic changes will be reflected in budget amendments.

The draft FY 2013 budget will be reviewed and approved at the June Steering Committee meeting scheduled for Wednesday, June 13, 2012, Kane Co. Emergency Services Training/Search & Rescue Facility, located at 30 West Airport Drive, Kanab, Utah.

I must also sadly bid farewell to **Darren Janes**, who is leaving the Association of Governments to pursue opportunities in the private sector along the Wasatch Front. Darren has devoted almost four years of effort in managing the district Revolving Loan Fund, administering the St. George Down Payment Assistance program, and providing senior planning support to many communities across the region. We will miss Darren's experience and hard work and wish him the best as he moves on with new challenges and opportunities. (Kenneth L. Sizemore)

Utah Lieutenant Governor Honors Lennie "Don" Porter

The Lieutenant Governor's Civic Volunteer of the Year Award honors an individual who has improved the quality of life in a community through BOTH political and non-political processes. Minimum qualifications are five years of continuous or near continuous service. How about 21 years? That's the qualifications of this year's recipient, Lennie "Don" Porter of Escalante. His long and distinguished career reflects his commitment to his community, family and the thousands of visitors to the Grand Staircase Escalante National Monument that require emergency services each year.

Beginning in 1991, Don joined the all volunteer Escalante Fire Department and the Garfield County Search and Rescue. His hard work and dedication was recognized in 1995 when he was appointed Fire Chief for Escalante City. In 1997 he received his EMT-B certification and started volunteering with the Garfield County Ambulance Service which is still on his to-do list today.

In May of 1997, he was asked by then Mayor Howard Miller to fill a vacant position on City Council. After serving two four-year terms, Don was then elected to the position of Mayor for the 2006-2010 terms.

Community Development Block Grant (CDBG) FY 2012 Fund Allocation

Each year the Five County region receives an allocation

of CDBG funds based upon a statewide formula utilizing a base amount (\$300,000) and a per capita population distribution. Funding for the FY 2012 program year totals \$950,764.

The Five County Association of Governments Regional Review Committee (RRC) has reviewed and approved the rating and ranking of projects for allocation of FY 2012 CDBG funds. Because of reallocated funds from a housing project that was not able to move forward, all applicants received funding and some were fortunate to receive all or part of the second year of multi-year funding.

FY 2012 program funds have been allocated to projects as follows: 1) Minersville Town, \$193,764-- Library expansion; 2) Hatch Town, \$150,000-- Procurement of a new fire truck; 3) Iron County, on behalf of Beryl Fire SSD, \$300,000-- Expansion of the Beryl Fire Station; 4) Big Water Town, \$150,000-- Sewer laterals for LMI households; 5) Orderville Town, \$67,000-- Red Hollow Wells backup generator; and 6) Five County Association of Governments, \$90,000-- To provide program administration, Consolidated Plan Planning, rating & ranking, housing program delivery, and economic development technical assistance and planning.

Future Road Projects Receive Funding



St. GEORGE, UT – Three government agencies joined forces in May to program \$46 million toward future road projects intended to alleviate and prevent traffic congestion in the St. George area.

St. George City, the Utah Department of Transportation (UDOT), and the Dixie Metropolitan Planning Organization (Dixie MPO) are interested in alleviating traffic congestion around the I-15 freeway exits at St. George Boulevard and at Green Springs along with the congestion on Bluff Street between St. George Boulevard and Sunset Ave.

Two Environmental Assessments nearing completion this summer have paved the way for road planners and engineers to soon begin design work on identified projects. The projects approved for funding include:

- A new interchange at Bluff Street and Red Hills Parkway-- \$14.7 million
- An I-15 interchange reconfiguration at MP 8-\$16.2 million
- Thru-Turn lanes at Bluff Street and St. George Boulevard-- \$12.8 million
- I-15 Auxiliary Lanes and improvements to frontage road intersections at I-15 Exits 8 and 10 -- \$3.5 million.

By programming funds in Fiscal Years 2013 through 2016, St. George City, UDOT and the Dixie MPO are showing their collective ownership and commitment to the needs of Washington County motorists and the traveling public. The planning and design process for these projects is expected to take two to three years before construction can begin.
