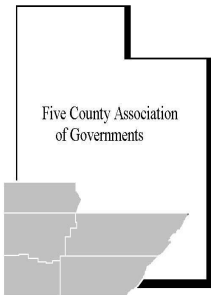

I am respected—and I am feared.

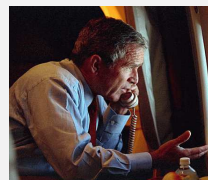
I have fought in every battle of every war for more than 200 years.

Long may I wave!



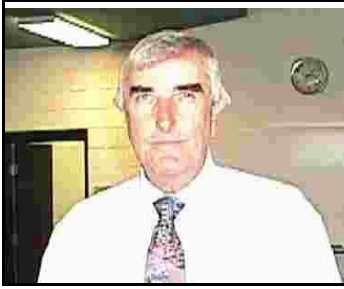
"...A great people has been moved to defend a great nation. Terrorist attacks can shake the foundations of our biggest buildings, but they cannot touch the foundation of America.

## Mayor Howard Pryor Lauded for Service

On August 22, 2001, the Utah Small Cities Community Development Block Grant (CDBG) Policy Committee met for its annual August meeting at the Utah Department of Community Development office building in Salt Lake City.

### The CDBG Policy

Committee is composed of seven members selected by the Governor from each of the seven regional districts in Utah. The Committee was formally established by a Governor's Executive Order dated November 1, 1986, and serves as the body which provides policy guidance the Utah Division of Community Development utilizes in administering the CDBG program. The representative that has served on behalf of the Five County Association of Governments region for the past 3 ½ years is Howard Pryor, Mayor of Minersville.

At the beginning of the meeting, two Committee members who have decided not to seek re-election to their respective offices, and thus not be eligible to continue to serve on the Committee, were recognized for their dedicated service to the residents of the State of Utah. Mayor Pryor is one of those two members.

Following some remarks by Gary Zabriskie, Associate Planner, FCAOG, in commendation of Mayor Pryor's service to the residents of the southwestern Utah, Committee Chairman Chesley Christensen, Mayor of Mt. Pleasant, presented an award plaque to Mayor Pryor, on behalf of the Utah Division of Community and Economic Development. The award honored Mayor Pryor's public service on the Committee. A similar presentation was also made to A. DeMar Mitchell, Mayor of Clinton. A hearty round of applause by all in attendance followed the presentation.

The handsome plaque presented to Mayor Pryor reads as follows:

## Weatherization Assistance Program

The Weatherization Assistance Program is a federal program locally administered by the Five County Association of Governments and managed by the Utah Department of Community Development/Office of Energy Service. The program is designed to help residents in the five county area—who meet federal low-income guidelines— to lower their utility bills and improve the comfort of their homes and is available to both homeowners and renters year-round.



Applications are available at the Five County AOG office, 906 North 1400 West, St. George, Utah or by calling 435-673-3548, and at Senior Citizen Centers and H.E.A.T. offices. Applicants are required to complete an application submitting verification of income, a utility fuel history, and a renter's agreement (if applicable). Applicants who qualify for the H.E.A.T. program are eligible for Weatherization; however, an application must be completed and sent to the Weatherization office.

Upon eligibility, an audit is performed on the home to determine what measures can be taken to make it more energy efficient. Some of the typical measures taken to improve energy consumption in homes are:

- ◆ **Heating safety and efficiency - Furnace tune-ups and replacement of filters and thermostats**
- ◆ **Installation of attic, wall, or floor insulation**
- ◆ **Weatherstripping and caulking**
- ◆ **Installation of water saving showerheads and energy saving light bulbs**
- ◆ **Replacement of broken glass in windows - window replacement, if allowed by energy audit**
- ◆ **Installation of water heater jackets**
- ◆ **Other work as deemed appropriate by energy audit and on-site home inspection**

The hardest part of our job is getting to all those who qualify in a timely manner. Due to the great response to this program, applicants may not be contacted for their home energy audit for 6-8 months. Our crew, Kirby Lambert, Doug Carlson, and Bryan Jackson, work year-round to complete weatherization measures for qualified homes. (Carolyn Moss)
