Director's Dialogue

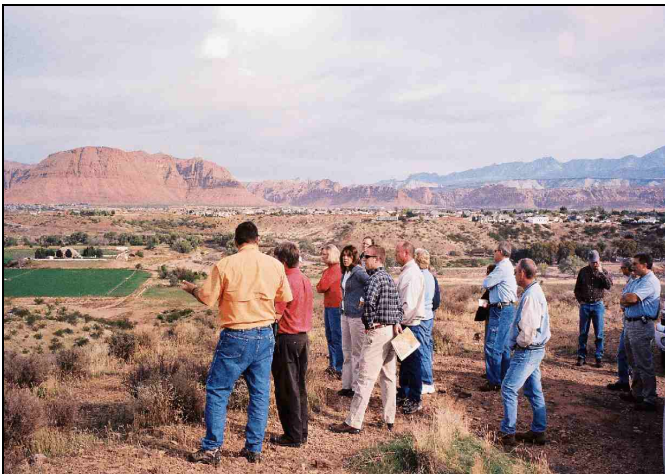

Western Corridor Field Trip

On Monday, November 2, 2005, the Dixie Metropolitan Planning organization held a field trip to the general area where a potential "Western Corridor" roadway may be developed.

The field trip was organized for members of the Dixie Transportation Executive Council, the Dixie Technical Advisory Committee, staff of the Utah Department of Transportation, the Federal Highway Administration, local

BLM Field Office, State Trust Lands Administration, as well as InterPlan the consulting firm preparing the corridor study.

Participants met early in the morning at Santa Clara City Hall to first travel to potential connections into the Santa Clara/Ivins area. Issues such as land ownership, potential engineering issues, etc. were discussed.

The group then traveled to the Bloomington area to begin the second part of the morning's field trip. The five four wheel drive vehicles carrying the entourage traveled out on the gravel road leading west from the end of Navajo Drive in Bloomington. This was to enable the group to get a perspective of the southern end of the potential Western Corridor.

The field trip was a good orientation activity and helpful to all of the participants in order to start identifying issues and concerns, and possible areas of agreement.

The "Western Corridor" will serve as a bypass for the residents and businesses in the western part of the county with a roadway between Santa Clara/Ivins area and the soon to be built new exit along I-15 near the Sun River development. (Gary Zabriskie)

Highway 143 Corridor Management Plan

Utah State Highway 143, known as the Brian Head-Panguitch Lake Scenic Byway, traverses the Markagunt Plateau in south central Utah from Parowan City, the county seat of Iron County, to Panguitch City, the county seat of Garfield County. The Byway is a 55 mile long route that traverses a wide variety of terrain and



Highway 143 received Utah Scenic Byway designation in 1989 and National Forest Byway designation in 2000.

In 2002 local stakeholders decided to come together and plan for the future of

the byway and to consider pursuing additional federal designation as either a National Scenic Byway or as an All-American Road. Through the collaborative effort of local stakeholders, the Community & Economic Development Division staff of the Five County Association of Governments is currently in the process of developing a Corridor Management Plan for Scenic Byway 143.

A series of planning meetings were held in Parowan, Brian Head and Panguitch. The Scenic Byway 143 Steering Committee along with local citizens and members of the Paiute Indian Tribe have been actively involved in the identification of intrinsic values located along the byway corridor. Intrinsic values are those qualities along the roadway corridor that can be clearly identified, documented, interpreted and which relate to byway travelers. The intrinsic values identified include archeological, cultural, historic, natural, recreational and scenic qualities. Currently text, photographs and mapping is being assembled into a draft document.

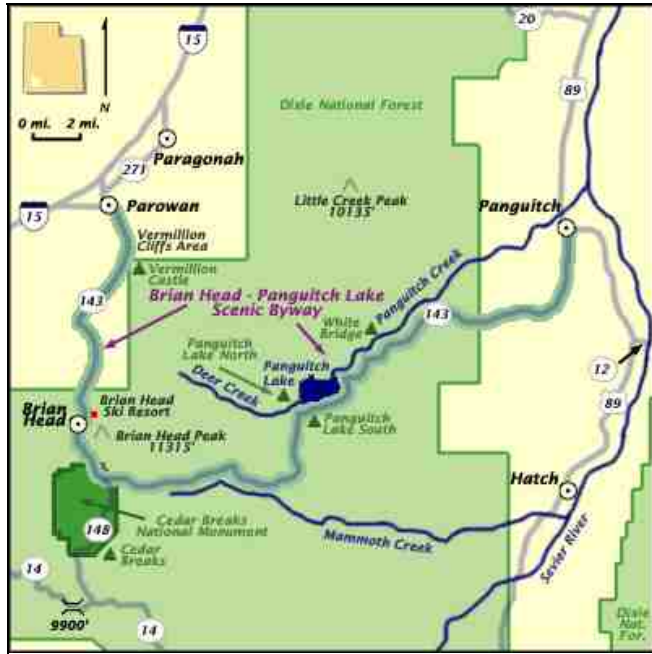
The final draft document will be presented to the public in a series of meetings scheduled as follows:
